

Board Minutes Monday June 11, 2012

The Board of Supervisors met as per adjournment with all members present.

Kaleb Michel presented a report of his research, restoration, and suggested future maintenance of the Lady Liberty statue on the Northwest corner of the Courthouse Square. With the Boards approval he plans to submit his report, plan documents, and certification by the Board as his Eagle Scout Project. Moved by Logsdon and seconded by Pierce to compliment and thank Michel on behalf of the residents of the County and approve his final report. Motion carried unanimously.

Moved by Bouska and seconded by Logsdon to approve the bid of \$6580.19 by Casper Plumbing and Heating for the repair and upgrade to the Air Conditioning system at the DHS building on Highway 52. Motion carried unanimously.

For the Republican party: County Supervisors District 1 – Dennis Karlsbrotten, District 2 – Floyd Ashbacher, District 3 – Les Askelson, District 4 – John Logsdon, District 5 – Lonnie Pierce, County Auditor – Benjamin D Steines, County Sheriff – Leon Francis Bohr . Motion carried unanimously. A true and correct abstract of votes cast is on file in the County Auditor's office.

Moved by Logsdon and seconded by Bouska to adopt resolution 12-055 granting permit to display fireworks to Jacob Seelinger. Motion carried unanimously by roll call vote.

Moved by Bouska and seconded by Pierce to approve the minutes for the Monday June 4, 2012 meeting. Motion carried unanimously.

Moved by Logsdon and seconded by Bouska to approve the Cigarette and Tobacco Permits for Sattre Store, Valley Inn, Winneshiek Coop/ Country Express, Highland General Store, and Harvest Farm Campground. Motion carried unanimously.

Moved by Bouska and seconded by Ibanez to approve the claims filed with the Board. Motion carried unanimously.
